BOMBAY SAPPERS ASSOCIATION MINUTES OF THE 64th MANAGEMENT COMMITTEE MEETING HELD ON 06 MAY 2022

- 1. The 64th Management Committee meeting of the Bombay Sappers Association was held on 06 May 2022 at 1100hrs in the Hall Of Generals at HQ BEG & Centre. The meeting was chaired by Brig DG Patwardhan, Commandant BEG & Centre and Vice Chairman, BSA.

3. At the outset, Maj Gen SG Pitre (Retd), Honorary General Secretary expressed that 01 May 2022 was a Red-Letter Day for the Corp of Engineers in general and for the Bombay Sappers in particular. Gen Manoj Pande has risen to the helm of the 1.2 million strong Indian Army by breaking many a glass ceiling by sheer dint of his exceptional ability and unceasing hard work. We the Bombay Sappers are very proud of him and wish him a rewarding innings as the COAS.

- 4. Director after seeking permission of the chair proceeded with the MCM. He gave out the agenda points to be discussed in the 64th MCM: -

Approval of Minutes of 63rd MCM

5. Director proposed that minutes of 63rd MCM (Last MCM held on 14 Feb 2022), be approved. The Director informed that the minutes have been circulated to all units and also uploaded on the BSA website and the Whats App group of ESMs. The approval of minutes was proposed by Maj Gen Pitre (Retd) and seconded by Col MM Bhushan (Retd).

BSA Activities held in Fin Yr 2021-22 till date.

- 6. **Membership of BSA**. The present state of members, who have paid life membership fees, as on 05th May2022 is:-

- 8. <u>Management Committee Meetings.</u> Director informed that we could hold only three meetings since April 2021. Meetings could not be held in the 3rd qtr due to the restrictions imposed due to the pandemic. Details are as follows
 - (a) 61st MCM held virtually through emails from 09th Apr to 21st Apr 2021.
 - (b) 62nd MCM held on 30th July 2021.
 - (c) 63rd MCM held on 14 Feb 2022

Boards held and expdr on various welfare schemes in Fin Year 2021-22

- 9. Director briefly gave details of boards held in the Fin Yr 2021-22 which were as follows: -
 - (a) **BSA Education Scholarship Scheme**. Board was held in Nov 2021 instead of Sept.
 - (i) Beneficiaries:48 Children of JCOs &157 Children of Other Ranks
 - (ii) Amount disbursed: Rs 2, 06,400/-
 - (b) <u>Education Grant for Children of Widows (EGCW)</u> Board was held in Nov 2021 instead of Oct.
 - (i) Beneficiaries: 159 children of 87 widows
 - (ii) Amount disbursed: Rs 5, 53,800/-
 - (c) <u>Distress Grant.</u> Three boards were held as per details given below:
 - (i) Beneficiaries: 14 (7 x ESM, 4x Serving members and 3x widows)
 - (ii) Amount disbursed Rs 1, 40,000/-. (Rs 10,000- each)
 - (d) <u>Immediate Relief</u>. Director informed that we had forty unfortunate death cases of serving JCO /ORs this financial year. An amount of Rs 4.0 Lacs was disbursed @ Rs 10,000/- each, to the widow/NOK.
 - (e) **Grant to widows for daughter's marriage:**
 - (i) Beneficiaries: 11 widows
 - (ii) Amount disbursed: Rs 2.75 Lacs

- (f) <u>Grant for professional Courses.</u> Board was held recently in March 2022 as admission process for all professional courses were delayed in Year 2021-22. There were still no applications from students of medical stream (as admission process is still going on), hence the board decided to keep two vacancies of medical stream pending and select only 8 students from other streams. A separate board for medical stream applicants will be held in May 22 as it is expected that the admission process will finish by May 2022.
- (i) Beneficiaries: 8 fresh awardees & 16 awardees of previous yrs
- (ii) Amount disbursed: Rs 2.4 lacs @ Rs 10,000/- each
- (g) <u>Madhuri Gupta Scholarship.</u> In this scheme also the board which was held in March 2022 decided to select one student from Engineering stream and keep one vacancy of the Medical Stream pending till May 22.
 - (i) Beneficiaries: 1 fresh awardees & 4 awardees of previous yrs
 - (ii) Amount disbursed: Rs 1.25 Lacs @ Rs 25,000/- each
- (h) <u>Col Kumar Scholarship.</u> This scholarship has been instituted w.e.f. this financial year 2021-22. The value of the scholarship is Rs 96000/- to be paid in four installments. **Master R Kaviarasan son of Sub R Rajendran (Retd)**, has been selected as the first awardee of this scheme. Amount of Rs 24000/- has been disbursed. The amount was paid from the Misc head of the budget, Provision for this scholarship under a separate head is being made in the budget of Fin Year 2022-23.

10. Director displayed the details of income and expdr for financial year 2021-22.

11. The director explained that the donations recd are shown as only Rs 2.765 lacs. However, we have recd donations of Rs 13.89 lacs in addition to the above, which have been taken directly in our corpus. Details of donations are shown at **Appx A**.

13. Director pointed out that under Aid to GBA we have spent Rs 3.8 Lacs instead of budgeted amount of Rs 3.5 lacs. This was done by utilizing the amount of Rs 30,000/-budgeted for the Indira Dassannacharya Scholarship which could not be utilised as the GBA was closed in August 2021. The savings from other heads was used to give additional grant for Sapper Sarais. He also pointed out that expenditure on felicitation of children joining NDA was met from the Misc head.

Audit Report of Chartered Accountant for Fin Year 2021-22

- 14. Director informed that the Chartered Accountants Audit was completed recently. He displayed the following statements from the audit report.
 - a) Receipts and payments account (01 Apr 21 to 31 Mar 22) attached as Appx B
 - b) Income and Expenditure account (01 Apr 21to 31Mar 22) attached as Appx C
 - c) Balance Sheet as on 31 Mar 2022 attached as Appx D
- 15. He brought out the following salient points of the report:
 - a) There were no objections or observations raised.
 - b) Excess income of Rs 44,186/- of previous year has been neutralized.

- c) Corpus value of our funds has increased by 43.5 lacs and now stands at Rs 5, 92, 34,830/- as on 31 March 2022. This is due to taking high value donations of Rs 13.89 lacs directly into corpus funds, transfer of 15% of this year's income i.e. Rs 2.26 lacs to corpus and new member's subscriptions of Rs 26.48 lacs.
- d) He pointed out that as on 31 Mar 2022, as per balance sheet, FDs held are for Rs 5,43,97,000/-, hence to ensure that our corpus remains untouched we need to invest Rs 48.37 lacs to match the value of corpus with FDs. He informed that we have already invested Rs 36 lacs in FDs in the month of April 2022 and we need to invest an additional amount of Rs 12 lacs more in this Fin Yr.
- 16. At this juncture Maj Gen SG Pitre pointed out that as the value of corpus and fixed deposits has grown substantially to more than Rs 5.5 Cr it is time we can think of spending some amount from the corpus to start a meaningful venture. He suggested that some time back when the old Gurnam Boys Hostel was shifted to the new building and renamed as Gurnam Boys Academy (GBA) an idea of opening a girl's hostel was discussed but was shelved at that time. However now that the NDA has also opened up for girls and as the environment has generally has changed, we could also give it a thought. The point was discussed and generally agreed upon that we should think of capping the corpus value and utilize funds for meaningful projects in future. Director pointed out that we should build up our corpus value till we get an annual interest of about 40 Lacs which is our annual requirement of funds.

Proposed Budget for 2022-23 .

17. The Director then proceeded to present the proposed budget for expenditure in financial year 2022-23. He displayed the figs for anticipated Income and Expenditure based on Income / Expenditure of last fin yr. These were as shown below:

18. Director explained that

- a) Anticipated income from interest on FDs is based on actual interest due from FDs held
- b) Income from duplicate cards was low in last two years due to pension batches not reporting to the BEG & Centre during the pandemic. However, they are reporting since Mar 22 hence income will go up.

- 19. Director gave following points regarding proposed expenditure under various heads.
 - a) The response for both Education Scholarship and EGCW is good this year and we have already received application in substantial numbers since April this year. Hence, he felt that expenditure on these heads will go up.
 - b) Grants for other scholarships schemes have been worked out on actual amounts required to be disbursed this year.
 - c) Amount required for felicitation of children joining NDA /IMA etc will be paid from the Misc head as few applications are expected.

- d) Aid to GBA is likely to go up as no of children registered has gone up and more ever one child of a JCO, who is residing in GBA, has lost both his parents in an unfortunate car accident. Hence as per our policy we will be catering for his entire expense from BSA funds. Hence, we have catered for Rs 5 lacs.
- e) Indira Dasannacharya Scholarship will be given this year as GBA has reopened.
- f) Grant for Sapper Sarais has been reduced this year as we have given substantial amounts in the last two years and more ever, we will be handing over the Sapper Sarai at Jalandhar to the Bengal Sappers as decided already.
- g) There is an increase in the salary head as the salary of BSA Clerk, Sub Ghatage (Retd) has been increased from Rs 14000/- to 15000/-.pm.
- h) He pointed out that this proposed budget requires to be approved tentatively by the MC and will be ratified during the Annual Gen Body Meeting (AGM).
- 20. <u>Felicitation of Children joining NDA etc.</u> Brig Patwardhan, Vice Chairman, at this juncture said that he has been talking about all BSA schemes during visits to regiments. He felt that applications from children joining NDA/IMA etc. is likely to go up. He said he met a JCO whose two children have been selected to join NDA & IMA. He had two points regarding this scheme.
 - a) The scheme should be extended to Bombay Sappers selected to join ACC.
 - b) NDA has started admitting girls from this year hence this scheme should also cater for a daughter of Bombay Sappers joining NDA / OTA in future.
- 21. The point was well taken and all members agreed that this should be done and promulgated immediately.
- 22. Funds for Sapper Sarai at Delhi Cantt.

 Brig Patwardhan at this juncture brought out that he visited the Sapper Sarai at Delhi Cantt during his visit to CEDU. He felt that there is a definite need to spend some funds and improve the infrastructure, especially as the facility is being used a lot not only by JCO /ORs but also by officers sometimes. Director also added that CO, CEDU had spoken to him regarding this and there is definitely a requirement to allot funds. He felt that we could review our proposed budget after seeing the expenditures in our scholarship schemes and all savings in these heads can be allotted to Sapper Sarai. Col A Chakravarty, CO Adam Bn at this juncture also said that no funds will be required by Sapper Sarai at Pune as it has been improved substantially during the last two years and also financially self-sufficient.
- 23 <u>Approval of Budget Fin Yr 2022-23</u> Director then requested members to approve the proposed budget for Financial Year 2022-23. The approval of the budget for Fin Yr 2022-23 was proposed by Col A. Chakravarty and seconded by Col Nidhi Roshyan.

Misc points from Director

24. Points given by Director and decisions taken on them are given in the succeeding paras:

- 25 **BSA Vehicle**. Director informed that per km hiring rates of the BSA Ertiga vehicle have been enhanced by Rs 2/- to Rs 17/-per km. This is due to tremendous increase in rates of Diesel. There ensued a discussion in which following points were brought out by members.
 - a) The vehicle is more than 4 yrs old and has done more than 1 lac kms. Hence it may have to be replaced in the next couple of years.
 - b) Nowadays Ola/Uber services are easily available hence utility of BSA vehicle is going down. Our vehicle is not being used for local duties except by few veteran officers. Hence it may be better; that we do not buy a new vehicle after this vehicle has lived its life
 - c) Most members agreed and felt we should not go for a new vehicle after this vehicle is discarded.
- 26. <u>Contribution from Maj R Dave for starting a new scheme.</u> Director informed, that as discussed in earlier MCMs, Maj R Dave has proposed to institute a scheme for persons in distress. He has promised to donate Rs 10 lacs as a corpus for the scheme. He has donated Rs 5 Lacs in Fin Yr 2021-22. Hence, the total amount donated to-date is now Rs 8 lacs. He has said he will donate the balance amount in this Fin Yr.
- 27. Shifting of BSA office to Maj RR Rane Empowerment Centre. Director informed that the building of the present BSA office is under demolition. It is planned to shift the BSA office to this new complex which is coming up in the Adam Bn, next to our present location. Col A. Chakravarty then gave a brief description of this upcoming project. The Empowerment Centre will have three wings. One wing will have the BSA complex to include the Directors Office, Waiting room for visitors, store room and office for BSA staff and a cafeteria. The other two wings will accommodate the Demobilization Office, Modern Smart Classrooms for running FORCE courses (Rehabilitation Courses). Computer Training Lab and offices for instructors/ faculty running various courses. A bust of Maj Rane will be installed in the central wing. It is estimated that this facility will be ready in the next six months. He also informed that Mrs. RR Rane has promised to donate an amount of Rs 20 lacs for this complex. Remaining funds will come from other sources. It was suggested by Maj Gen SG Pitre (Retd) that we should plan to get this complex inaugurated by the COAS during the Group Day celebrations in January 2023.
- 28. <u>Annual Gen Body Meeting</u>. Director informed that we need to organize and hold the AGM at the earliest as it is a statutory requirement. He requested the Hony Gen Secy to either write or speak to the chairman regarding this. Vice Chairman said that we will hold our AGM along with the Commanding Officers Trg Conf.

Points from Members of MC.

- 29. <u>Handing over of Sapper Sarai at Jalandhar</u>. Vice chairman informed that the Col Commandant / Chairman BSA has agreed with this and action to hand over the facility is in hand.
- 30. Opening up of GBA to Children of other Regts
 Vice Chairman said that the Col Comdt has agreed on this point. Soon we will work out on 1/3 rd seats to be opened up for children of Bengal/Madras Sappers, MLI, Sikh LI and may be Mahar Regts to begin with. Col A. Chakravarty, CO Adam Bn informed that registration of children of Bombay Sappers has already has gone up to 36. He also informed that we have recently employed a well qualified and motivated JCO as the warden for GBA. He was the warden of the SC Boys hostel which has been closed now. Track record of this JCO is very good and it is hoped that we will see positive results in the near future.

31. There being no other points the 64th MCM was thereafter declared as closed.
