WEF 04 AUG 2025 TO 04 SEP 2025**

**Special Instructions**

1. All aspects of terms and conditions of service for persons enrolled through the **Agnipath Scheme for service in the IA** are available on home page of **www.joinindianarmy.nic.in**.
2. Agniveer Recruitment Rally under UHQ quota will be conducted wef **04 Aug 2025 to 04 Sep 2025** for enrolment of Agniveers for the wards (Son/Brother) of Ex-Servicemen/Serving Soldiers/Widows/War Widows as per priority given in IHQ of MoD (Army) letter No 62536/Rtg 5(OR)(A) dt 12 Sep 2007 as amended vide letter No 62527/Rtg B (A) dt 20 Jul 2021.
3. Enrolment will be conducted strictly in accordance with the instructions given in 'Recruitment Directive for Recruitment of JCOs/OR-2014' and various recruitment policies issued by the competent authorities from time to time. Common Entrance Exam is tentatively scheduled on 2<sup>nd</sup> / 3<sup>rd</sup> week of Sep 2025 which will be intimated to all selected in physical screening. Candidates are required to report at Nanda Gate, BEG & Centre, Khadki at 0500hrs for initial screening. **No Candidate will be permitted to enter the rally site after 0800hrs. Open category candidates will not be accepted for recruitment except Tdn Musician category and Sportsmen sponsored by HQ BEG & Centre Khadki, GS (Sports) Branch.** For Agniveer Sportsmen (Open Category) Recruitment:-
  - 3.1. Candidates of under mentioned sports discipline will be assessed by Prelim Board of Officers ordered by GS Branch, HQ BEG & Centre, Khadki wef **25 Jul 2025** :-
    - 3.1.1. Football
    - 3.1.2. Swimming
    - 3.1.3. Hockey
    - 3.1.4. Basketball
    - 3.1.4. Rowing
    - 3.1.5. Sailing
    - 3.1.6. Triathlon
  - 3.2. Only Recommended Candidates Sponsored by HQ BEG & Centre, GS (Sports) will be allowed to appear in physical screening fitness test and physical measurement test by rect BOO on **04 Aug 2025**.
4. Units may sponsor sportsmen in specified list games as per Policy Directive 2014 and Dte Gen of Rtg, Rtg B (A), IHQ of MoD (Army) letter No. 62541/Rtg B (A) dt 06 Jul 2020, who have Represented India at the International Level and State at the Senior/Junior National level. Only Sports Certificates issued by Recognised National Sports Federations would be considered. The validity period of Sports Certificate produced by the candidate will be two years on the first day of the rect rally from issuing date. **Units are requested to fwd the certificate of potential screened candidates direct to HQ BEG & Centre, GS (Sports) Branch Khadki, by 18 Jul 2025.**

## Criteria for Enrolment

5. **Education, Age Criteria and details of vacancies available in various cat.** Details of education and age criteria applicable for enrolment and details of vacancies available in various categories are given at **Appendix 'A'**.

6. **Physical Criteria.** Details of physical criteria and relaxation for various categories are given at **Appendix 'B'**.

7. **Age Variation.** A difference of **366 days** is accepted as **minor variation**. Any variation beyond **366 days** between the date of birth mentioned in Education Certificate/Birth certificate and Field Service docu/Relationship Cert of serving/ex-servicemen, will be treated as **major variation** and such candidates will **NOT be eligible** for enrolment under UHQ quota. (Auth: IHQ of MoD (Army) letter No 62554/Rtg 5 (OR) (A) dt 25 Jan 2010).

8. **Document Required.** List of required documents are given at **Appendix 'C'**.

9. **Marital Status.** Only **unmarried candidates** will be eligible for enrolment as Agniveers and will remain so during the defined engagement period of four years. If any candidate who is married and below 21 years of age will not be eligible for Agniveer recruitment except in case of real brother of battle casualty who has married widow of the battle casualty. In such cases, docus will be fwd to Rtg Dte for waiver of the QR by the competent authority. Enrolled candidates who are above 21 years of age will not ask for any married accommodation or any other allied privileges available to married personnel during training. A certificate to this effect will be rendered by the candidate in accordance with IHQ of MoD (Army) letter No 62569/Rtg 5 (OR) (A) dt 07 Feb 2007.

10. **Priority.** The priority will be given as laid down in page No 176 of Recruitment Directive for Recruitment of JCOs/OR-2014 issued by Dte Gen of Rtg/Rtg B, AG's Branch, IHQ of MoD (Army) is as under:-

10.1. **Priority 1. (Own Regt/ Corps Battle Casualty/Liberalised Family Pension.)**

10.1.1. **One son** of war widow in receipt of Liberalised Family Pension to include legally adopted son.

10.1.2. **Real brother of battle casualty who marries the widow of the battle casualty.** In this regard, refer Integrated HQ of MoD (Army) letter No 62569/Inst/Rtg 5 (OR) (A) dt 20 Apr 2007 vide which it has been intimated that in case any candidate below 21 yrs married to the widow of the deceased, S of C is to be forwarded to Dte Gen of Rtg through the line Directorate for waiver of the QR by the Competent Authority.

10.1.3. **One son-in-law** of battle casualty **having no son** to include husband of legally adopted daughter.

10.1.4. **One real brother** of unmarried battle casualty.

10.2. **Priority 2. (Own Regt/Corps) (Disability Pension/Special Family Pensioners).**

10.2.1. In respect of Serviceman who **die in harness**, **one son/** one legally adopted son or **one real brother (if the serviceman is unmarried)** where the Widow/NOK is in receipt of Special Family Pension.

10.2.2. **One son/one** legally adopted son of ex-serviceman or **one real brother (if the ex- serviceman is unmarried)** in receipt of Disability pension more than 20% and the disability is attributed to/aggravated by Military Service.

10.3. **Priority 3. (Own Regt/Corps) (Serving/Ex-Serviceman).**

10.3.1. **One son of** Serviceman who **die in harness** to include legally adopted son whose death is **not attributed to military service**.

10.3.2. **One son of Serviceman/Ex-Serviceman** to include legally adopted son.

10.3.3. **One brother of Serviceman/Ex-Serviceman.**



**10.4. Priority 4. (Other Regt/Corps).**

10.4.1. One son of war widow to include legally adopted son.

10.4.2. Real brother of battle cas who marries the widow. In this regard, refer IHQ of MoD (Army) letter No 62569/Inst/Rtg 5 (OR) (A) dt 20 Apr 2007 vide which it has been intimated that in case of any candidates below 21 yrs married to the widow of the deceased brother, S of C be forwarded to IHQ of MoD (Army) Rtg 5 (OR) (A) for waiver of the QR by the competent authority.

10.4.3. One son-in-law of war widow having no son to include husband of legally adopted daughter.

10.4.4. One real brother of unmarried battle casualty.

**10.5. Priority 5. (Other Regt/Corps).**

10.5.1. As per priority 2 and 3 given in Paras 10.2 & 10.3 above for own Regt/Corps to be implemented in respect of other Regt/Corps in the same order/precedence.

10.5.2. Wards of TA pers.


**11. As a Priority I to Priority V Candidate.** Under each of these priorities, it is clearly stated that only one son and one brother can participate in UHQ rally. The second son or the second brother can only be allowed to participate, if the 1<sup>st</sup> son or brother has not been selected in previous UHQ rally. It implies that two sons or two brothers cannot participate together in the same UHQ rally on the basis of the same relationship cert. (Auth: Dte Gen of Rtg, Rtg B(A) letter No 62527/Rtg B (A) dt 20 Jul 2021).

**12. Instant Enrolment of Wards of Battle Casualties.** Wards of battle casualties will be enrolled under Instant enrolment as laid down by Dte Gen of Rtg, Rtg B (A), IHQ of MoD (Army) letter No 62569/Inst Enrol/Rtg B (A) dt 14 Dec 2023 and 62569/Inst Enrol/Rtg B (A) dt 12 Mar 2024.

**13. Enrolment of Son / Brother.** Only one son/brother of servicemen/ex-servicemen can participate in UHQ Rally and will be eligible for bonus mks on the Relationship certificate as laid down vide Dte Gen of Rtg, Rtg B (A), IHQ of MoD (Army) letter No 62527/Rtg B (A) dt 29 Jan 2025.

**14. General Guidelines Against Malpractices.**

14.1. The complete process is transparent with different sets of assessors/examiners for different Selection/screening processes. There are five separate board of officers whose functional flow-chart is as under:-

14.2. Candidate who give **fake certificates** will be **handed over to the Civil Police**.

14.3. All candidates including parents are advised to refrain from contacting touts/agents. In such cases the police will be called in and the candidature of the individual shall be rendered null and void.

14.4. No combatant will make an effort to contact any candidate and vice versa.

14.5. The place of Agniveer recruitment is **OUT OF BOUNDS** for all ranks.

14.6. No staff in the Centre will visit the place of Agniveer recruitment unless called for by the Presiding Officer.

14.7. No candidate will contact the Agniveer recruitment staff. Such cases will be handed over to the Civil Police and candidature shall be cancelled.

14.8. Wards of civ employee who are paid out of Def estimates, BSF, Air Force, Navy, GREF, Assam Rifles and MES are not permitted to attend the said Agniveer recruitment rally.

14.9. No travelling allowances/dearness allowance is admissible.

14.10. The UHQ Agniveer recruitment rally in this Centre will be video recorded including all physical, medical and written tests.

15. **Cut Off Date.** The cut of date of candidate will be worked out as per the date of birth mentioned in the matriculation certificate as on **01 Oct 2025** in accordance with Dir Gen of Rtg, Rtg B (A), IHQ of MoD (Army) letter No 62554/Rtg B (A) dt 22 Sep 2021. Date of birth for each trade/category should be as under:-

16.3. **Physical Measurement Test (PMT).** Height, Weight, Chest in accordance with DGMS (Army)/DGMS-5A letter No 76063/Policy/DGMS-5A dt 24 Jan 2024.

16.4. Detailed document check and prep of Recruits Master Data Sheet (RMDS).

16.5. Primary Medical Examination and Review Cases.

16.6. Preparation and issue of Admit Card.

16.7. Conduct of Common Entrance Examination.

16.8. **Adaptability Test.** All candidates who qualifies the Physical Fitness Test (PFT) & Physical Measurement Test (PMT) will have to undertake Adaptability Test as per policy in vogue. Adaptability Test is for selection of candidates who can adapt to the environment of the Indian Army and are able to adapt to the challenges of military life. Those candidates who will qualify the Adaptability Test (Psychometric Test) will be eligible for medical & further recruitment process. Those candidate who do not qualify the Adaptability Test will not be allowed for further participation in recruitment process. Candidates will be allowed to carry their Smart Phones for the duration of Adaptability Test (**Auth** : Dte Gen of Rtg, Rtg B (A), IHQ of MoD (Army) letter No 62536/Rtg B (A) dt 07 May 2024).

17. **Standard for Weight.** Weight should be proportionate to height as per Appx to DGMS (Army)/DGMS-5A letter No 76063/Policy/DGMS-5A dt 24 Jan 2024 are given at **Appendix 'D'**.

18. **Warning Against Use of Performance Enhancing Drugs (PED):-**

18.1. Consumption of drugs will be checked before and after 1.6 Km run.

18.2. Candidates will be disqualified for use of Physical performance enhancing drugs during Agniveer recruitment rally.

18.3. Army will not be responsible for any mishappening during the run/other physical test due to consumption of PED.

18.4. Consumption of such drugs can result in a heart attack or fatal symptoms during the 1.6 Km run/other physical test.

18.5. Luggage of all candidates is liable to be searched for any contraband items.

18.6. Random on the spot tests for Performance Enhancing Drugs (PED) will be carried out during Physical Screening Test of candidates.

19. **Cautionary Notice.**

19.1. Candidates are warned not to pay any money to any agent/tout or make any kind of favourable arrangement with them as there is no way that they can influence recruiting process.

19.2. BEG & Centre, Khadki is **not responsible** for any injury or death caused to a candidate in the Agniveer recruitment rally, **candidates will participates at their own risk.** The Centre reserves the right to reject a candidate at any stage of the Agniveer recruitment process if the candidate does not fulfil mandatory QRs or furnish incorrect/false documents.

19.3. Agniveer Recruitment is free and candidates are cautioned against falling victim to unscrupulous AGENT/TOUTS.

19.4. Elements/middlemen/agents/touts will only mislead candidates. Paying money to agents/touts is a crime and a total waste. Nothing can stop a deserving candidate from getting enrolment and nobody can influence the Agniveer recruitment process at this Centre.



19.5. Candidates must take care of documents/belongings against theft during the rally. BEG & Centre, Khadki is **not responsible** for the same.

19.6. Candidates are advised to report to the rally site strictly as per program given to **avoid overcrowding** and unnecessary inconvenience to other eligible participants.

19.7. At the rally site, all candidates should report duly shaved (beard, chest hair, axillary hair, pubic hair and with crew hair cut (except Sikh candidates), for identification at various stages of rally process failing which candidate can be barred from participation in Agniveer recruitment rally.

19.8. Candidates may have to present themselves at rally site for two to three times. Candidates should make arrangements for this duration of stay under their own arrangements.

19.9. Candidates are advised in their own interest to undergo medical exam before coming for selection especially with respect to flat foot, poor vision, deformities and physical measurements. All are advised to ensure that ears are free of wax by getting it cleaned by a doctor prior to the rally.

19.10. If 180 days or more lapse between screening medical at the rally and dispatch, medical will be done again and unfit candidates in this review will not be recruited.

19.11. No use of contact lenses is allowed.

19.12. Negative marking will be applicable in CEE.

19.13. Bonus marks in CEE for Agniveers in accordance with Dir Gen of Rtg, Rtg B (A), IHQ of MoD letter No 62568/Rtg B (A) dt 13 Feb 2023 are as under :-

**Note :-**

- The above marks are fixed depending upon the eligibility of a candidate and has no relation to his performance in Common Entrance Examination (CEE).
- Only one type of Bonus Marks (Max of the permissible) will be added to the total.
- Bonus marks will be accorded on qualifying in the written examination.
- Only one ward (daughter/son) of Service/Ex-Servicemen/War Widow/Widow of Ex-Servicemen can avail bonus marks in written examination.
- Original Certificate to be carried by all above categories at rally site.
- Sports Certificate are valid for two years from the issue date as on first day of the Agniveer recruitment rally for which the candidate is being screened.



20. **Result of written examination will be declared on the official website of Bombay Sappers Association i.e. [www.bsakirkee.org](http://www.bsakirkee.org).** It is responsibility of candidate to check his result.

21. **Physical Screening Programme.** Physical screening programme of Agniveer recruitment rally is as per **Appendix 'E'**

22. **Terms and Conditions.**

22.1. **Enrolment.**

22.1.1. Candidates will be enrolled under Army Act 1950 for a service duration of four (04) years including the training period.

22.1.2. Agniveers so enrolled will be subject to Army Act 1950 and will be liable to go wherever ordered, by Land, Sea or Air.

22.1.3. Agniveers enrolled under the scheme, will not be eligible for any kind of Pension or Gratuity.

22.2. **Service.**

22.2.1. Service of Agniveers will commence from the date of enrolment.

22.2.2. Agniveers would form a distinct rank in the IA, different from any other existing ranks.

22.2.3. Leave, Uniform, Pay & Allowances during the service period of four years will be governed by orders and instructions in respect of such individuals issued by the Government of India (GoI) from time to time.

22.2.4. Agniveers will be liable to be assigned any duty in organisational interest, as decided from time to time.

22.2.5. Personal enrolled through Agniveers Scheme, will be required to undergo periodical medical check-ups and physical/ written/ field tests as governed by orders issued. The performance so demonstrated would be considered for subsequent offer for enrolment in the Regular Cadre.

22.2.6. Agniveers can be posted to any regiment/unit and can be further transferred in organisational interest.

22.3. **Discharge.**

22.3.1. All Agniveers will be discharged on completion of four years of service.

22.3.2. On discharge after completion of four years, Agniveers will be paid a 'Seva Nidhi' package to enable them to return to the society for pursuing employment in other sectors.

22.3.3. Agniveers will not be eligible for any kind of pension or gratuity, neither will they be eligible for Ex-Servicemen Contributory Health Scheme (ECHS), Canteen Stores Department (CSD) facilities, Ex-Serviceman status and other related benefits.

22.3.4. Agniveers will be barred from disclosing classified information gained during service to any unauthorised person or source under Official Secrets Act, 1923.



## 22.4. Enrolment for Regular Cadre.

22.4.1. Based on organizational requirements and policies promulgated Agniveers who are completing their engagement period in each batch will be offered an opportunity to apply for enrolment in the regular cadre of IA. These applications will be considered in a centralised manner by the army based on an objective criteria including performance during their engagement period and not more than 25% of each specific batch of Agniveers will be enrolled in regular cadre of the IA, post completion of their four years engagement period.

22.4.2. Agniveers so enrolled as regular cadre would be required to serve for a further engagement period of 15 years and will be governed by terms and conditions of service (of Junior Commissioned Officers/Other Ranks in IA) currently in vogue (as amended from time to time). Agniveers will not have any right to be selected. Selection will be exclusive jurisdiction of the IA.

22.4.3. With introduction of this Scheme, the enrolment of Soldiers in the regular cadre of IA, except technical cadres of Medical Branch, will be available only to those personnel who have completed their engagement period as Agniveer.

## 23. Employability.

23.1. Agniveers will be liable to be assigned any duty in organisational interest, as decided from time to time.

23.2. Agniveers can be posted to any regiment/unit and can be further transferred to other regiments/ units in organisational interest.

24. **Leave.** Grant of leave will be subject to exigencies of service. The following leave may be applicable for Agniveers during their engagement period:-

24.1. **Annual Leave.** Upto 30 days per year.

24.2. **Sick Leave.** Based on medical advice.

## 25. Pay, Allowances & Allied Benefits.

### 25.1. Agniveer Package.

25.1.1. The pay & emoluments of Agniveers will be as given below :-

25.1.1.1.	<b>Year 1.</b>	Customised Package – Rs.30,000/- (plus applicable allowances)
25.1.1.2.	<b>Year 2.</b>	Customised Package – Rs.33,000/- (plus applicable allowances)
25.1.1.3.	<b>Year 3.</b>	Customised Package – Rs.36,500/- (plus applicable allowances)
25.1.1.4.	<b>Year 4.</b>	Customised Package – Rs.40,000/- (plus applicable allowances)

25.1.2. From the above package, 30% will be compulsorily deposited every month in a corpus which will be matched by the GoI. Balance amount less the corpus contribution will be the in-hand component.



25.2. **Seva Nidhi Package.** On discharge at 04 years, the corpus of Rs.5.02 lakhs will be matched by the Gol, an amount of Rs.10.04 lakhs and accrued interest will be given to the Agniveers. In case of Agniveers who are subsequently selected for enrolment in IA as regular cadre, the "Seva Nidhi" package to be paid to them will comprise only their contribution including accrued interest thereon. In the case of Agniveers exiting service before the end of their engagement period on their own request, the individual's Seva Nidhi package, accumulated as on date, will be paid with the applicable rate of interest. In such cases, no Govt contribution to Seva Nidhi Package will be entitled. The "Seva Nidhi" will be exempt from Income Tax.

25.3. **Payment Modality - Seva Nidhi Package.** Two options to receive Seva Nidhi Package will be provided to each Agniveer, with an aim to provide financial loans for self employment/ entrepreneurship through a bank guarantee as also to meet immediate/incidental expenses, on exit. Firm details will be promulgated separately.

25.4. **Allowances.** The Agniveer pay is a composite package and he will not be eligible for any Dearness Allowance and Military Service Pay. He will get applicable Risk & Hardship, Ration, Dress and Travel Allowances as decided by the Gol from time to time.

25.5. Agniveers will be exempted from making any contribution in Armed Forces Personnel Provident Fund or any other Provident Fund.

25.6. There shall be no entitlement towards gratuity or pensionary benefits for Agniveers enrolled through this Scheme.

26. **Life insurance Cover.** Agniveer will be provided non-contributory life insurance cover of Rs.48 lakhs for the duration of their engagement period and they will not be eligible for Army Group Insurance Fund (AGIF) Schemes/benefits.

27. **Termination/Release from Service.**

27.1. The maximum period of service for Agniveers will be as enumerated at Para 20 above. However, the services of Agniveers under this scheme may be terminated at any time in accordance with the Army Act 1950.

27.2. Release at own request prior to completion of terms of engagement of Agniveers is not permitted. However, in most exceptional cases, personnel enrolled under this scheme may be released, if sanctioned by competent authority.

27.3. **Compensation for Death** Agniveers will be governed by provisions contained in the Pension Regulation for Army (as amended from time to time). They would be suitably compensated for death. The death for the purpose of provision of financial benefits to Agniveers will be categorized as follows:-

27.3.1. **Category X.** Death due to natural causes neither attributable to nor aggravated by military service.

27.3.2. **Category Y.** Death due to causes which are accepted as attributable to or aggravated by military service or due to accidents/mishaps in the performance of duties including training.

27.3.3. **Category Z.** Death due to acts of violence / attack by terrorists, anti social elements, enemy, during border skirmishes/ war/ peacekeeping operations/ aid to civil power etc, and during operational / preparation and training for war including battle inoculation training/ exercises and accidental deaths due to natural calamities/ operations specially notified by Gol etc.



27.4. **Compensation for Disability.** In case an individual is placed in a permanent Low Medial Category (LMC). The authorities will assess the percentage of disability/ Attributability. In case of disability (attributed / aggravated due to service conditions), one time ex-gratia as mentioned below will be granted Computation of extent of disability will be as under :-

28. **Benefits for Personnel Exiting at Four Years of Service.** After completing four years of service (as applicable), the following benefits will be offered to the exiting individuals:-

28.1. **Seva Nidhi Package.** Refer Para 22.2 above. The corpus generated after four years of contribution will be paid to the exiting Agniveers.

28.2. **'Agniveer' Skill Certificate.** At the end of engagement period, a detailed Skill set certificate will be provided to the Agniveers, highlighting the skills and level of competency acquired by the personnel during their engagement period.

28.3. **Class 12<sup>th</sup> Certificate.** Agniveers who have been enrolled after qualifying Class 10<sup>th</sup>, a certificate for 12<sup>th</sup> (equivalent) will be given on completion of their 04 years engagement period, based on skills attained. Detailed instructions shall be issued separately.

29. **Special Instructions.**

29.1. 01 Oct 2025 will be taken as effective date of determining age eligible for candidate. Candidates to produce birth certificate at the time of preliminary documents check.

29.2. Candidates are required to report at the Rally Site by 0500 Hours on their respective scheduled dates. Candidates reporting after 0800 Hours without appropriate justification will not be permitted to participate in the Rally. **Candidates should be clean shaven** (Except Sikh Candidates).



29.3. Personnel e-mail ID/Mobile Number is **MUST**. All important messages will be sent to this e-mail ID/Mobile Number like short listed/call letter/joining instruction/result etc. sharing of e-mail ID and Mobile Number is not permitted. Remember the User Name and Password for future use. (This Centre will not be responsible for not getting required information if e-mail/Mobile Number of candidates given wrong/changed).

29.4. Candidate must carry their AADHAR Card which will be authenticated biometrically at the Rally Site. Ensure AADHAR details are matching with the detailed mentioned in the documents.

29.5. Candidates Name Fathers Name, Mothers Name and DOB must be tally as per Matriculation/10<sup>th</sup> Class Board Certificate.

29.6. Those not in possession of required documents will not be permitted to participate in the Rally.

29.7. **Touts.** In the past, a number of candidates have been found victims of touts, fake documents/impersonation and in the bargain have lost their candidature. Modus operandi/means used by the touts are as under:-

29.7.1. Issue of fake PFT Slips/Impersonation during various stages of rally. Conduct fake Agniveer recruitment rallies.

29.7.2. Snatching/taking away original certificates from candidates who have been declared fit at initial stage and thereafter harassing them.

29.7.3. Taking away "ADMIT CARD" from the candidates under plea that they will follow up their results.

29.7.4. Giving candidates false assurance of "RECRUITMENT" as they claim to have links at appropriate level, thereby winning confidence of candidates.

29.7.5. Once a candidate gets through on his own efforts touts demand money in return of the original certificates.

29.8. **For 8th Class Pass Candidates.** 8<sup>th</sup> class pass mark sheet and transfer certificate issued by school (both certificate) should be countersigned by District Inspector of School/District Education Officer.

29.9. A Grievance Cell will be established at the Rally Site to redress any grievances.


29.10. Candidates are requested to report at rally site with proper shave and hair cut so as to ensure proper identification & Medical Review.

29.11. Agniveer Recruitment is purely based on merit list depending on available vacancies. Candidates do not have any right to claim recruitment in Army just for passing in recruitment process.

29.12. Candidates not in possession of requisite certificates are liable for rejection.

### Important Instructions

30. Recruitment into the Army is a free service. Candidates are advised not to pay bribe to anyone for recruitment as it is based purely on merit. Selection process during recruitment at all stages is computerized and transparent. Therefore, candidates are advised to be beware of touts as they cannot help them at any stage.



31. Giving/taking bribe, production of bogus/fake certificates and indulging in unfair means is a criminal offence and liable for punishment under law.
32. Candidates are advised to check their age & education criteria before participating in the rally. Candidates found under age/overage and not meeting education criteria will be disqualified.
33. Certificates with overwriting or tampering of seals or erasing/alteration of any type will not be accepted.
34. All documents submitted by the candidates are verified by government agencies before enrolment into Army. Strong legal action will be taken against individuals submitting fake documents. Even after recruitment, the service will be terminated if candidates are found to have produced fake documents or gave wrong information at the time of recruitment, despite the number of years of service individual may have rendered.
35. No compensation for Death/Injury/loss etc during the rally and no travelling allowance/dearness allowance for journey is admissible. Candidates will participate in the rally at their own risk and the participation is totally and entirely voluntary. The signing of Indemnity Bond is a mandatory requirement.
36. Character certificate without photo attested by certificate issuing authority will be rejected.
37. **Use of Performance Enhancing Drugs.** Use of any kind of performance enhancing drugs is strictly banned. Any candidate found to have used the same will be debarred from further screening.
38. **Tattoo.**

38.1. Candidates belonging to tribal communities/from tribal areas, are permitted to have permanent body tattoos on any part of the body, as per existing customs and traditions of the said tribe to which a candidate belongs. Such candidates will only be permitted on producing the following two certificates:-

38.1.1. Self certification certificate to be signed by the candidates is attached as **Appendix 'F'**.


38.2. Certificate of belonging to a tribal community and permissibility of permanent Body Tattoo(s) to be signed by DC/DM or SDM of the District/Tehsil where the tribe of the candidates is presently settled is attached as **Appendix 'G'** (Name and designation of the concerned official must be clearly mentioned).

38.3. Permanent body tattoos of religious sentiment are only permitted on inner face of forearms i.e from inside of elbow to the wrist and on the reverse side of palm/back (dorsal) side of hand. Permanent body tattoos on any other part of the body are not acceptable and candidates will be barred from further selection.

Mobile phones are not permitted in the rally site and CEE except during Adaptability Test.

1.1.1. Education Certificates with marks sheet in original of all educational qualifications achieved by candidate i.e. Matric/Intermediate/Graduation etc from recognized School/College/Board/University.

1.1.2. Provisional/online education certificate should be certified ink signed by the head of the educational institution of concerned Board/University.

1.1.3. Candidates with matric certificate from open school should bring school Leaving Certificate countersigned by BEO/DEO.

1.1.4. 8<sup>th</sup> class pass certificate and mark sheet in original will only be acceptable if countersigned by the DEO/CEO/ZEO. (Applicable for House Keeper only)

1.1.5. All candidates are advised to check their education mark sheets and board certificates issued by Recognized State Education Board/ Universities. Updated list of recognized educational institutions is att at **Annex-I** (Auth:- Dte Gen of Rtg, Rtg B (A) IHQ of MoD (Army) letter No 62533/Rtg B (A) dt 21 May 2025).

**1.2. Relationship Certificate** SOS/SOEX/SOW/SOWW candidates are required to produce the following documents:-

1.2.1. Relationship certificate issued from respective Record Office only duly signed by Senior Record Officer with Personal number, Rank, Name and particular of the Record Officer issuing the Relationship Certificate with office seal/stamp is endorsed. Relationship certificate should bear water marks of the concern Records.

1.2.2. Original Discharge Book of Ex-Servicemen also to be produced. Name and date of birth of the candidate must have been recorded in it.

1.4. **Character Certificates.** Character Certificate with photograph issued by Village Sarpanch/School/college Principal/Ward Master (**validity within last six months**).

1.5. **Unmarried Certificate.** Unmarried Certificate for candidates less than 21 years of age with photograph issued by Village Sarpanch/ Ward Master (**validity within last six months**).

1.6. **Domicile / Permanent Residence / Nativity Certificate.** Domicile / Permanent Residence Certificate with photograph issued by Tehsildar/District Magistrate.
